

## PROPOSED BYLAW CHANGE FROM DISTRICT 142 EXECUTIVE BOARD

District: District 142

Bylaw Article & Section: Article 11, Section 4Proposed Effective Date: May 1, 2025Rationale for Change: Remove and place in District 142 operational policy, re-letter paragraphs.

## CURRENT LANGUAGE:

**Section 4** The duties of the full-time Communications Director, Communicator, and Educator shall be as follows:

- a. Dissemination of information to the membership and interfacing with the news media, website designs and social media and any other communications as approved by the President/Directing General Chair.
- For the faithful performance of her/his duties, the District Lodge 142 Communicator and Educator shall receive a salary of \$750.00 per month and shall follow directions from the District Lodge 142 President/Directing General Chair.
- c. For the faithful performance of her/his duties, the full-time District Lodge 142 Director of Communications, shall receive a salary equal to that of the full-time District Lodge 142 "Organizer".
- d. The Full-time Director of Communications, Communicator and Educator shall attend all meetings of the Executive Board and may entertain discussion, but no vote.
- e. The Full-time Director of Communications, Communicator and Educator shall be responsible for organizing and shall be responsible to the President/Directing General Chair.
- f. The Full-time Director of Communications, Communicator and Educator will keep the President/Directing General Chair advised of their whereabouts at all times when on assigned District Lodge 142 business and shall, each week, give a written report of their day-to-day activities.
- g. The Full-time Director of Communications will be granted an annual vacation equal to that which s/he would receive, under the terms of their CBA.
- j. The Full-time Director of Communications will receive a per diem while away from her/his designated headquarters in the regular performance of his duties. A per diem will be paid in the same manner as a District Lodge 142 General Chair.

## **PROPOSED CHANGE:**

**Section 4** The duties of the full-time Communication Director, Communicator and Educator shall be as follows:

- a. Dissemination of information to the membership and interfacing with the news media, website designs, social media, and any other communications as approved by the President/Directing General Chair.
